

## **New Communications Data Regulations**

**Part 1 Chapter 2 of the Regulation of Investigatory Powers Act 2000 (RIPA)** gives local authorities and other public sector organisations, including fire and ambulance services, the power to access communications data e.g. mobile phone, postal, e mail and website data.

Further to the consultation on Part 1 Chapter 2 of RIPA conducted last year, the Home Office has published a new statutory Instrument which (subject to parliamentary approval) will come into force on 6<sup>th</sup> April 2010.

### **The Regulation of Investigatory Powers (Communications Data) Order 2010:**

- Consolidates three previous orders (SI2003/3172, SI2005/1083 and SI2006/1878) which set out (within each public authority) what data could be accessed, for what purposes and who can authorise it.
- Maintains the grounds for which an authorisation could be given by a local authority for accessing communications data; section 22(2)(b) - i.e. for the purpose of preventing or detecting crime or of preventing disorder
- Revises the prescribed officers who can sign authorisations for local authorities to be "Director, Head of Service, Service Manager or equivalent"
- Revises the prescribed the prescribed officers who can sign authorisations for other public authorities to take account of organisational changes as well as the change of certain senior job titles e.g. fire authorities, IPCC etc.
